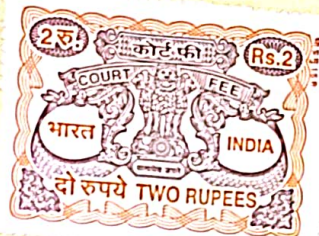
01. That "SHRIMATI RAJO DEVI SOCIAL AND EDUCATIONAL TRUST" is a registered Company under the company act of 1956.

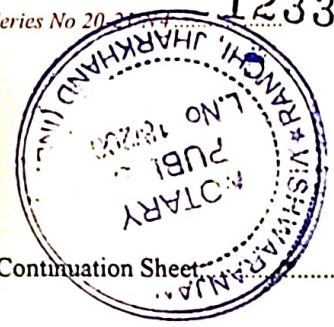

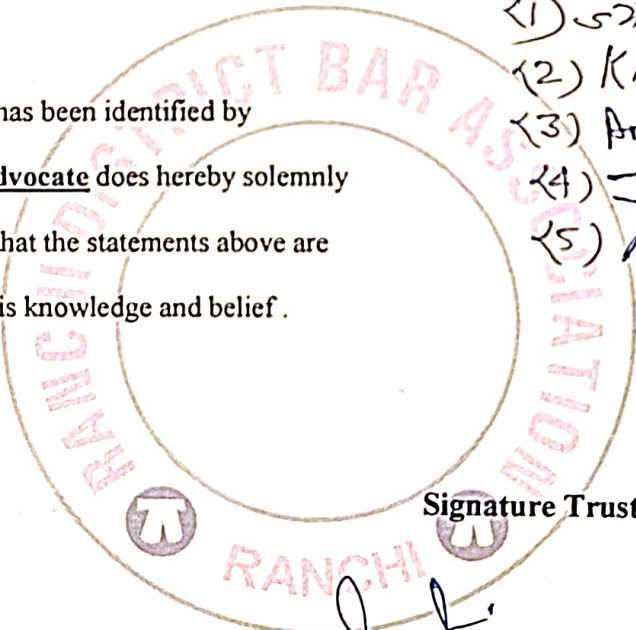

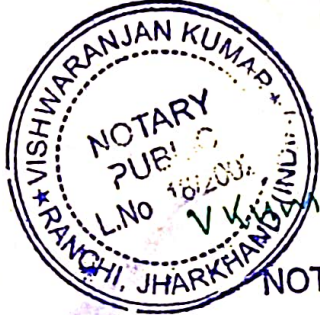
